1. *The Dudhauli Municipality, Office of Municipal Executive, has allocated funds* towards the cost of *Badareghat Pakkipool Nirman Ward No. 13* and intends to apply part of the funds to cover eligible payments under the Contract *for Badareghat Pakkipool Nirman Ward No. 13 (17/NCB/WORKS/DMUN/2080-81)*. Bidding is open to all eligible as per Section V of bidding document.
2. *The Dudhauli Municipality* invites electronic bids from eligible bidders for the construction of *Badareghat Pakkipool Nirman Ward No. 13* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **5,50,00,000/- (Five Crore Fifty Lakhs Only)**
  - Minimum Work experience of similar size and nature **One (1) Bridge Construction Contract within the last ten (10) years, with a value of at least NRs. 2,80,00,000/- ( Two Crores Eighty Lakhs Only) without VAT.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder Shall submit their bid electronically and may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document (**5,000/-**) in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at *Dudhauli Municipality Office* on **2081-02-20** at 2:00 PM.
7. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon** on **2081-02-31**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend on **14:00 Hours** on **2081-02-31** at the office of *Dudhauli Municipality, Dudhauli-09, Sindhuli*.
9. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **13,50,000/- ( Thirteen Lakhs Fifty Thousands Only)** which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission
